6.1 Update on efforts to obtain quotes for repairs to the Case 440 backhoe. Donella has contacted a man recommended to her by Don Fossi backhoe. He said he can work on the brakes and do an oil change at the beginning of October (after harvesting is done).

6.2 Follow up the discussion on the need for completing a new section of the cemetery and to start preparation of a minimum of 50 x 50 foot. Determine location and discuss the proposed new Veteran's section in conjunction with the new general burial space. NOTE: Immediate action is needed to start the prep work on the general burial area.

And it is complicated even more by the fact that we can't provide any kind of identifier. It was suggested that we need to do a new title search.
